## What is this product?

#### Type:

This product is a physically backed exchange traded certificate. These are secured, limited recourse certificates.

#### Term:

This product has a final maturity date of 31 December 2100. The Manufacturer has the right to terminate the product in a limited number of circumstances, as set out in the prospectus.

#### **Objectives:**

The Invesco Physical Gold ETC aims to provide the performance of the spot gold price through certificates collateralised with gold bullion.

The base currency is USD.

# What are the risks and what could I get in return?

#### **Risk Indicator**



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

#### Intended Retail Investor:

This product is intended for investors who are willing to invest for a long term and who plan to stay invested for at least 5 years. Investors should be prepared to take on a relatively high level of risk of loss to their original capital in order to get a higher potential return.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the ability for you to receive a positive return on your investment.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency from your local currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

#### Recommended holding period: 5 years

This product has no required minimum holding period however we have selected 5 years as the recommended holding period as the product invests for the long term therefore you should be prepared to stay invested for at least 5 years.

You can sell your shares in the product during this period, subject to satisfying certain criteria as set out in the prospectus, or hold the investment longer. If you sell some or all of your investment before 5 years the product will be less likely to achieve its objectives, however, you will not incur any additional costs by doing so.
