Objectives

WisdomTree Cocoa is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Cocoa futures contracts. The ETC aims to replicate the Bloomberg Cocoa Sub Total Return Index (BCOMCCTR) by tracking the Bloomberg Cocoa Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Cocoa Sub Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Cocoa Sub Total Return Index falls by 1% over a day, then the ETC will fish product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result

in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts. Intended Retail Investor

Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product. The Issuer is entitled to terminate this product unilaterally.



What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 1 year. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Cocoa between 03/05/2016 and 20/04/2017.
